- 7. Strategic Plan Update Benchmark 2: Teaching and Learning: The 1st internal Math benchmark has been completed and is still being scored.
 - 8. School Director Report: The school is fully enrolled with 304 students, approved for 300. The Charter School Office visit is completed, the visitors were complimentary and will likely go before the Board of Regents in April. Intensive instructional coaching is occurring in 1st and 4th grade, with Math and ELA Coordinators and School Director teaching lessons and small groups. Help is being provided with management and organization. Another teacher resigned, interviews are scheduled but candidates are not coming for the interviews. Teaching Assistants are being hired to support with several maternity leaves. TA provided with stipend for additional duties. Sara Castner has reached out to local colleges to recruit December graduates.L. Bridges will reach out to Charter Champion for more info on recruits.
